MOTION AND JOURNAL ENTRY ON MUNICIPAL C

This matter came before the Court November 1, 2024, on the Court's own motion and pursuant to Local Rule 503(D). The Court finds that exhibits admitted into evidence in the case numbers set forth in the attachment, and other miscellaneous items in the Court's possession, are no longer needed for the reason that litigation in the cases has concluded, including times for direct appeal. The Court hereby notifies the parties tendering the exhibits that the parties may retrieve the exhibits, excluding illegal drugs or contraband, within 60 days from the date of this notification. The exhibits will be destroyed, if not retrieved within 60 days of this notification. The exhibits may be retrieved in the Judge's chambers upon making prior arrangements with the Court's Bailiff.

Now, therefore, the Court ORDERS that the exhibits shall be destroyed appropriately by the Court's Bailiff in 60 days as follows: marijuana shall be burned; marijuana drug paraphernalia shall be destroyed and disposed of safety; prescription medication shall be disposed of properly; documents and CDs shall be shredded; and miscellaneous items shall be destroyed and disposed of safely. The Court further ORDERS the Clerk of Courts to publish a copy of this ORDER and the attachment on the Court's website for 60 days.
